Fly Out to Arthur Dunn on March 1, 2008

By now everyone is aware of the tragedy at Titusville on March 1, in which Chapter 99 member Don K. lost his life and member Ueli C. got severely injured. While flying to the breakfast at Arthur Dunn, Titusville, FL they were involved in a collision with another aircraft. A memorial service was held for Don on Sat. March 8, 2008. On March 21, after a couple of surgeries Ueli was in stable condition and was flown with an ambulance flight back to a hospital in Switzerland.
