### PIREPS

#### Fly Out to Piper at Lock Haven, PA Submitted by Gerd

While visiting Pennsylvania in June, we could not resist to see the birth place of Landis and Piper (there is no doubt that both are connected forever).

We flew to Lancaster, PA (KLNS) in two legs with a stop in Grand Strand (KCRE). Although we flew IFR, most of the time the conditions were nice VFR. After a couple of days exploring the Amish Country we picked a day for a VFR flight over the Harrisburg nuclear power plant, the Gettysburg battlefields and then northeast towards Lock Haven, PA (KLHV). After landing at Piper Memorial Airfield, the nice FBO guy gave us a ride to the Piper museum, which is right on the field.

The museum is small, it only occupies one floor of the building and an adjacent hangar, but you can get a really good overview of the airplanes Piper built and learn a lot about the Piper family (see also [www.pipermuseum.com](http://www.pipermuseum.com)). There is a simulator room and several exhibits, like "The Early Years", "The War Years", "The PA-29 Papoose" (yes, Landis' airplane is there too), "The Metal Airplanes" and even "Piper at Vero Beach, FL". In the hangar they have (among others) a PA-23, the PA-12 "City of Angels", several cubs and a Cheyenne LS 400 fuselage on display. Our tour guide loved to hear that we were from Vero Beach, and related a lot of insider stories.

Before heading back to Vero Beach, our last stop was to be Pocono Mountains Wolfs Lodge, which is a big hotel with an indoor waterpark (just for the kids, of course). Since the weather seemed to clear up and we did not want to get into the thunderstorms, we took off VFR from Lancaster. Halfway there, Pocono

Mountains (KMPO) was still IFR and it was obvious that we would soon enter the clouds. Radar looked o.k. and the stormscope didn't show anything so we finally dared to ask the helpful controller from Allentown approach for an IFR clearance. Our flight ended after a GPS 13 approach circling 23 right at minimums. Now I know first hand why airlines are not allowed to do circling approaches and I surely do not want to try this one at night. For a flatlander like me, the whole trip to PA was an interesting lesson on local weather patterns.
