## ETHANOL FUEL DRAMA

At the last meeting Chapter 99 members learned of the problems encountered by Jim Davis when he unknowingly refueled his airplane with autofuel containing ethanol. EAA Chapter 193 in Jacksonville, FL has encountered similar problems and is doing something about it. They are starting a movement to win some relief from the ethanol



mandate on auto gas that was recently signed into law. They are asking local chapters to assist them with the goal to have premium auto fuel exempted from ethanol so that pilots who fly with an STC would be able to safely keep fueling their aircraft. Chapter 99 needs a volunteer to coordinate this activity. In the meantime, ethanol free fuel can be bought at most marinas or COMO Oil Co. at 1731 Commerce Avenue in Vero Beach.

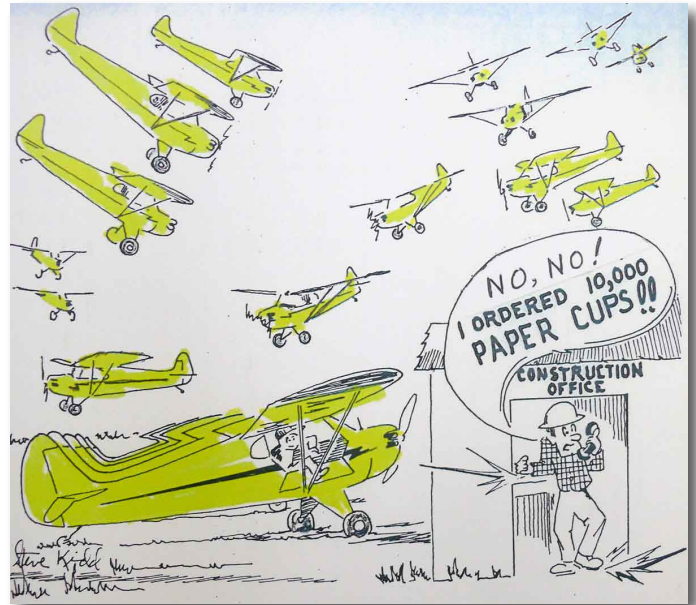
