## **PLANE FUN**

### **JULY Mystery Plane:**

No one correctly identified the July mystery Plane.



**The Seabird Seeker** was developed by Seabird Aviation, Hervey Bay, Queensland, Australia and made its first flight in 1989. It is still being built there, and by Seabird Aviation in Jordan, however rights to the type certificate have recently been bought by Seeker Aircraft, Albuquerque, New Mexico. It was specifically designed to fill the role of an observation aircraft and be more economical to operate than a helicopter. It has served in a military role in Iraq and Afghanistan, game-park patrols in Tanzania and South Africa, police and border patrols in Ghana and New Mexico, surveillance, pipeline patrols, and photography in Australia. Its benign stall characteristics, short take-off and landing capabilities, and excellent visibility make it ideal for these types of operations. Crew accommodation is for 2 people only.

It is ruggedly built of all-metal construction with a pusher propeller and a 270 degree visibility cockpit. Hard-points on each wing allow external pods to be fitted and under fuselage mounts allow a wide array of spotlights, infra-red detectors and cameras to be attached. Power was originally supplied by a Lycoming O-360, 180 hp engine but now most versions are fitted with the Lycoming O-390, 210 hp engine. 28-volt electrical power is supplied by 2 alternators.

### **Specifications:**

Wingspan: 36 feet, Fuselage length: 23 feet, Max T/o weight 2040 lbs., Max speed (Vne) 129 kts., Minimum patrol speed: 65 Kts. Stall speed: 48 kts. Range: 475 nm, Patrol endurance: 7 hrs & 15 min, T/o roll: 780 feet, landing roll: 654 feet.

### **Third Class Medical Reform: Important!**

The Air Line Pilots Association International (ALPA) has renewed its opposition to "Third Class Medical Reform" legislation that is being considered by congress. Why they have done this is a mystery since it puts them at odds with the rest of the aviation community and their membership. Learn more about what is

happening in the first and second parts of this [AOPA video release](#). We need to get this legislation done! If you have not contacted your Senators (Bill Nelson) and Representatives (Bill Posey), it is imperative that you do so as soon as possible and ask them to co-sponsor and support S. 571 and H.R. 1062, the "Pilot's Bill of Rights 2". EAA helped to draft the newly introduced twin bills, and they already have bipartisan support from top lawmakers. The bill aims to allow pilots flying certain aircraft to operate using a driver's license in lieu of a traditional third-class medical, and it will build upon the first Pilot's Bill of Rights in ensuring that pilots and other airman are given due process in enforcement proceeding.
